New data has been added from crossfiles on DVD. New 2011-data has been added from crossfiles on DVD. Now data consist of crossfiles for 2006-2011 and former data divided on calendar year for 2000-2005.

For export-subsidies in cross-files for 2006-2011 the authority don't provide a budgetline (F109). They all get the 8-digit budgetline 05000000.

Old documentation:

The feoga-year is defined by the payday. All before 16th of October 2007 are 2007. All others are 2008. The data has not been giving out by the authority before.

All the raw data on x-files are stored in other databases due to space-reason. In the database for the web, all the payments for all years are collected.

The data is in the database 2008x-files3-recipient. Payment data from x-files need to be added to payment – else recipient and budgetlines are updated. The total dataset for 2008 are in the database 2008x-files3, in access2007.

Danish data

Danish data has been handed out in several versions - the first for the years 2002 and 2003 from the authorities in May 2004 in several csv-files. In total we have until now got data from the years 2000-2004 in 12 different files. Divided on year and source we have this picture:

Danish journalists got the data after 1½ years fighting in a FOI-case. The data is an extract of the actual files transferred from the paying authority to the Danish Tax Authority. It consist of all payments from Direktoratet for FødevareErhverv - it means also some national schemes are included in this total overview of payments.

Some data is missing in some of the rows. It can be name of the beneficiaries, adresses or the whole information besides scheme and amount. In total both name and business identifier is missing in:

The authorities write the name and adress in different ways, so it's difficult to make a clean search and get all relevant data for one beneficiaries. Information on county and municipality is not included. We have geocoded the data to get the exact place and from here extracted county and municipality. In total 49.995 payments can not be placed in a county and municipality. It is 2 pct. of all the money and 7 pct. of all payments.

Some beneficiaries, like Arla, has a lot of different names and adresses. We analyze this by searching all names and adresses to get a total picture. In total over the five years Arla receive the highest amount of money. In total Arla get € 761.768.983 in 516 payments over these years divided to 93 different recipients (different spellings, different addresses, different business id's, etc.).

Combining data like this makes it possible to make a list of the biggest recipients in Denmark. This is top-100, where number 5 is all the cases where the authorities have denied access to information on both the recipient name and business-id:

Using this method we have in total 76.519 different recipients in Denmark - by geocoding and saying recipients with same business-id is the same and we then present the name of the business-id, which receives the highest amount of money. If there's no name here, we take another name. And then also checking data for the biggest recipients manually like the Arla-case. From the beginning we can divide payments to 156.426 different recipients. By clicking on one of ours summarized recipients you can get all the different payments and

recipients summarized under this person/organisation.
